Communique on the 41st Ordinary Session of the African Committee of Experts on the Rights and Welfare of the Child, Maseru, Lesotho,

26 April-06 May 2023

- 1. The 41st Ordinary Session of the African Committee of Experts on the Rights and Welfare of the Child (ACERWC) was held on 28 April-06 May 2023 in Maseru, Lesotho. The Session was attended by members of the Committee and other stakeholders, including Representatives of children, Representatives of Member States, Representatives of the African Union Commission and AU Organs, Representatives of UN Agencies, Representatives of National Human Right Institutions and Civil Society Organizations.
- 2. The Opening Ceremony of the Session had remarks from:

The opening ceremony was followed by solidarity statements from CSOs and NHRIs as well as Members of the Africa Governance Architecture platform, which included presentations from the AGA-APSA Secretariat, the African Commission on Human and Pope's Rights, the African Court on Human and Peoples' Rights, APRM, AU-ECOSOCC, on relevant activities and potential synergies with the ACERWC.
